



<u>Idea: Providing technical equipment in schools for use in the</u> <u>activities of local companies</u>

Idea description

Title:	Providing technical equipment in schools to be used in the activities of local companies.
Idea objective	The objective of this activity is to reduce the operating costs of enterprises by providing them with specific infrastructure/equipment used on a daily basis for educational purposes in schools. The essence of this action is to involve the resources and knowledge of students and teachers in solving problems and securing the technical and organizational needs of local companies. The action consists of establishing cooperation among enterprises and local schools (each level, profile and field of study), under which the enterprise will gain access to tools, equipment, school infrastructure in order to prepare/carry out its own economic processes. An important aspect of the action is the assumption that the sharing process will not violate or limit students' access to these resources as part of educational activities at school. School resources should be shared on the basis of prepared regulations, taking into account the principles of sharing, making repairs, supervision, covering the costs of repairs and materials, depreciation, etc. The action should be supervised by the entity that runs the school (office) in the field of the necessary legal regulations. Variants of the implementation of the action: 1. The implementation of the measure may include involving students in the process of sharing resources, e.g. through student projects carried out on school equipment for local companies. 2. The action may require the introduction of security mechanisms in the form of deposits, mandatory insurance or related solutions.
Sharing process (max 1000 characters)	Implementation of the action requires the following steps: 1. Defining the subject of sharing: a. On the side of schools: i. inventory of technical resources (equipment) of schools, determining the possibility of transferring resources in the sharing model, ii. preparation of rules for the use of school resources by enterprises (regulations, contract templates, etc.), iii. organization of the process of sharing resources (registration of company needs, schedule, monitoring, settlement, etc.), b. On the side of companies in the City - defining the demand for the use of school equipment. 2. Preparation of the offer and its communication in the City. 3. Implementation of the action.
Restrictions/rules (law, skills, time, other)	The action requires defining the rules for using school resources, taking into account the legal regulations defining: - principles of conducting educational activity in public institutions, - the method of financing the purchases of shared resources, - the rights and obligations of the parties involved, - other elements that will be affected by the implementation of the measure.
Procedures (if applicable)	The action requires the preparation of dedicated administrative procedures corresponding to the scope and subject of shared resources.
