



Idea: Free premises for organising trainings for target groups in entrepreneurship field by external partners (projects)

Idea description

Title:	Free premises (e.g. the local youth resource centre) for organising trainings for women
1106:	entrepreneurships by external partners (projects) incl. events addressed to Ukrainians
Idea objective	The aim of the initiative is focuses on the creating good conditions for projects implementation and trainings addressed to the local business. The idea is also encouraging private companies to get involve in projects for capacity building in the field of entrepreneurship. The main propose of the initiative is offering free premises by the public authorities/institutions for organizing trainings for target groups – e.g. women or young entrepreneurship. The initiative can also include aspects related to Ukrainians refugees. The local public authority/institution can be a partner within the project or not (other local entities can contact LPAs and ask for cooperation). Trainings can be only one component of a larger project. The project can be regional, national or international. The goal is to have free spaces for a certain number of persons and other facilities for organizing events/trainings. The alternative of the idea could include some other available public resources (not mandatory spaces) – it might be flipchart tables, computers, etc. The use limits are established by the public partner (period of usage, requirements, etc.).
Sharing process (max 1000 characters)	 The implementation of the idea needs the following activity: To define the specific needs for organizing trainings (technical aspects – number of people, facilities, resource type, etc.) To establish the cooperation framework (duties and responsibilities of all parts, periods, etc.) and roles To plan a mutual calendar in case of regular trainings/resource usage To formulate the communication rules Initiative implementation (usage of the resources) Handing back the resources to the public authority
Restrictions/rules (law, skills, time, other)	Knowledge/competency limitations: Depending on the specifics of the project and resources type needs, public institutions may have gaps in the resource availability and regulation on their operations. This may require the involvement of additional specialists. The activity may encounter procedural problems related to access to public resources and the involvement of public employees of other institutions (e.g., local government and/or government).
Procedures (if applicable)	In the organization phase, necessary to carry out a formal procedure defining the manner and form of space/resource sharing operation. In the implementation phase, it is necessary to apply administrative procedures that allow cooperation with other public institutions for access to specific resources (if applicable).
Costs for public institutions (if applicable)	The initiative doesn't generate significant additional costs. The need to guarantee access to public infrastructure (space or other resources) in a public institution.
Expected result (if possible)	Public space sharing or other specific resources sharing by the public authority for providing capacity building activities in entrepreneurship field to specific target groups: women, youth, Ukrainian refugees, etc.
