| Idea objective | The idea is to prepare and support in the implementation of web page, that is built by students of the local vocational school. In the original action, students supported SME business which was based in education for transport rules - students prepare a novel web design according to new requirements of the market with a focus on online resources distribution. The intention of the initiative is reduction of costs for the company but also to build the practical relation between students, school and market body. For companies, the fact the webpage was created on local level gives security for the future as the correction or repair process can be easily organised by the school. In the times of rising costs of IT tools and limited IT resources on the market (lack of skilled people), using school resources can by important alternative, and in the sharing economy model the way to protect companies from losing the market in more and more digitalised world. Other options connected to the idea: organisation wider cooperation between different schools/profiles in order to organise wider offer including text preparation, copywriter, design and graphics, online shops, advance option (e.g. augmented reality), organise open call for local enthusiasts that will work in the school teams and support local companies. |
